Two Critically Important Pro-Life Bills Set for Votes Late Monday; Contacts Requested

Two critically important pro-life bills will be voted on by the Oklahoma House Judiciary Committee Monday afternoon at 4:30. The committee will consider Rep. Pam Peterson's **Abortion Reporting bill, HB 3284**, and Rep. Lisa Billy's **Ultrasound bill, HB 2780**.

The bills to be voted on Monday afternoon are the following:

HB 3284 (Rep. Pam Peterson), reporting abortions performed in Oklahoma, the reasons abortions are sought, and the complications that result;

HB 2780 (Rep. Lisa Billy), providing a woman an ultrasound of her unborn child which she may view prior to undergoing an abortion.

Please also contact your own state representative and urge support for these pro-life bills when they reach the House floor a few days from now. Type your address, then scroll down to the fifth entry for name and contact information for your representative.

Our efforts this session are devoted to enacting seven separate bills to reclaim the pro-life gains of the past two years. Oklahoma County district courts have blocked enforcement of pro-life laws enacted in 2008 and 2009 based on

claims by the abortion industry that the laws do not comply with the nebulous, subjective "single-subject" rule of the state constitution.
