Oklahomans For Life - LEGISLATIVE ALERT - REVISED

March 9th, 2008

Senate to vote on Conscience bill; House to vote on four pro-life bills; email support now

The state Senate will vote this week on Senator Todd Lamb's pro-life **SB 1878**. The *Freedom of Conscience Act* would protect health care professionals' right to refuse to participate in the taking of an innocent human life.



It is urgent that senators hear at once from their pro-life constituents asking **support** for **SB 1878**.

You could identify your state senator by going to our website, www.OkForLife.org. On the upper left side of the home page, click on *Identify Your Legislators*. Type your address, then scroll down to the fourth entry. A link to your state senator's email address is shown.

Your message, in your own words, could be as short as: *Senator, as your constituent, I ask that you please support Sen. Lamb's **SB 1878**, protecting health care professionals' right to refuse to participate in the destruction of an innocent human life.*

In addition, please contact your state representative in the Oklahoma House and request support for the four pro-life bills that will be voted on this week:

HB 3144, by Rep. Lisa Billy, providing a woman an ultrasound of her unborn child which she may view prior to undergoing an abortion;

HB 3059, by Rep. Rebecca Hamilton, ensuring that a mother's consent to an abortion be truly voluntary, and safeguarding against coerced abortions;

HB 2771, by Rep. Pam Peterson, protecting health care professionals' freedom of conscience and right to refuse to participate in the taking of a human life;

HB 2181, by Rep. Skye McNiell, regulating the use of the dangerous chemical abortion pill RU-486, used when the unborn child is about two months old.

Your message could be very simple: *I live in your district and ask that you please support the four pro- life bills: **HB 3144, HB 3059, HB 2771, HB 2181.***

You can identify your state representative by referring to the third paragraph of this Alert and scrolling down to the fifth entry (just below your state senator). A link to your representative's email address is shown.
