### Senate vote looms on crucial pro-life bill; Email support now; phone Governor to sign bill

Please send an email **now** to [Senate@OKForLife.org](mailto:Senate@OKForLife.org) (which will reach the members of the state Senate with just one click) urging support for the pro-life bill, SB 1878. The bill passed the House last Wednesday, but the Senate poses a more difficult challenge, and the unborn child needs every bit of help we can give.



Please send an email even if you have sent one previously; your email to the address in the paragraph above will reach many senators simultaneously. Please do so immediately. The Senate vote could occur at any time on **pro-life SB 1878**.

On the SUBJECT line of your email, you could put **Please support pro-life bill** or **Please vote for SB 1878** or **Please defend the unborn child**.

**Dear Senator** would be a proper way to begin. Please urge, in your own words, **support** for **SB 1878**, the **pro-life bill** that helps pregnant women, unborn children, pro-life health-care professionals, and persons with disabilities.

You need not give your address or hometown since you will be reaching senators from across the state who represent all Oklahomans.

It is also vital that **Governor Brad Henry** hear from pro-life Oklahomans urging him to sign **SB 1878** into law. Governor Henry's office phone number is (405) 521-2342.

**SB 1878** has five parts:

- 1) protecting health care professionals' freedom of conscience and right to refuse to participate in the taking of an innocent human life;
- 2) regulating the use of the dangerous chemical abortion pill RU-486, used when the unborn child is about two months old;
- 3) ensuring that a mother's consent to an abortion is truly voluntary, and safeguarding against coerced abortions;
- 4) providing a woman an ultrasound of her unborn child which she may view prior to undergoing an abortion; and

5) fostering respect for children with disabilities by disallowing wrongful-life lawsuits which claim that a baby would have been better off being aborted.

It is critical that senators hear at once from pro-life Oklahomans asking support for SB 1878. Please email now to [Senate@OKForLife.org](mailto:Senate@OKForLife.org).
